

**City of Midway City Council Regular Meeting  
Monday, May 2, 2022, 5:30 p.m.**

The regular meeting of the Midway City Council was called to order by Mayor Grayson Vandegrift. The following Council Members were present: Sara Hicks, Logan Nance, Mary Raglin, Steve Simoff, and Stacy Thurman. Kaye Nita Gallagher was absent. Also present were Clerk Cindy Foster, Versailles Police, and the Woodford Sun. Guests Lisa Shelborne, Cecelia Gass, and Jeremy Divine attended.

**Approval of Minutes**

Approval of April 4, 2022, Regular Meeting Minutes – Motion to approve by Council Member Nance; second by Council Member Hicks; all in favor; motion passed 5-0.

Approval of April 18, 2022, Regular Meeting Minutes – Motion to approve by Council Member Thurman; second by Council Member Simoff; all in favor; motion passed 5-0.

**New Business**

Event Permit for Ragner Events LLC was tabled until the next meeting due to lack of information.

Walter Bradley Park Manager, Jeremy Divine, presented an update on Walter Bradley Park improvements made in 2021. Cecelia Gass presented a budget request for 2022/2023 from the Friends of Walter Bradley Park for \$20,600.00 for park improvements.

Mayor Vandegrift presented a request from a resident on Elkton Place to make the street a one-way street. Resident Lisa Shelbourne represented herself and other residents on Elkton Place who oppose the request. The request died due to lack of a motion by the City Council.

Mayor Vandegrift presented bids for surplus equipment. The Council voted as follows:

- Council Member Nance made a motion to accept the bid from Sherman Green for the Homesteader Trailer for \$2,050.00; Council Member Hicks seconded the motion; all in favor; motion passed 5-0.
- Council Member Nance made a motion to accept the bid from Clay Conner for the 2002 Ford F-150 pick-up truck for \$150.00; Council Member Hicks seconded the motion; all in favor; motion passed 5-0.
- Council Member Hicks made a motion to accept the bid from Jeff Reed for the Sull Air Compressor for \$6,000.00; Council Member Raglin seconded the motion; all in favor; motion passed 5-0.
- Council Member Nance made a motion to accept the bid from Jeff Reed for a jack hammer and bits for \$300.00; Council Member Simoff seconded the motion; all in favor; motion passed 5-0.
- Council Member Nance made a motion to accept the bid from Jeff Reed for a Kohler generator for \$1,000.00; Council Member Thurman seconded the motion; all in favor; motion passed 5-0.
- The City Council decided not to accept the bids on the 2016 Exmark mower.


**Reading of Resolution**

Council Member Hicks requested the reading of Resolution 2022-006, a Resolution Authorizing the City of Midway to Use the Standard Allowance for the Local Fiscal Recovery Fund as Authorized by the American Rescue Plan Act. Mayor Vandegrift presented the resolution. Council Member Hicks made a motion to accept; Council Member Raglin seconded the motion; all in favor; motion passed 5-0.
